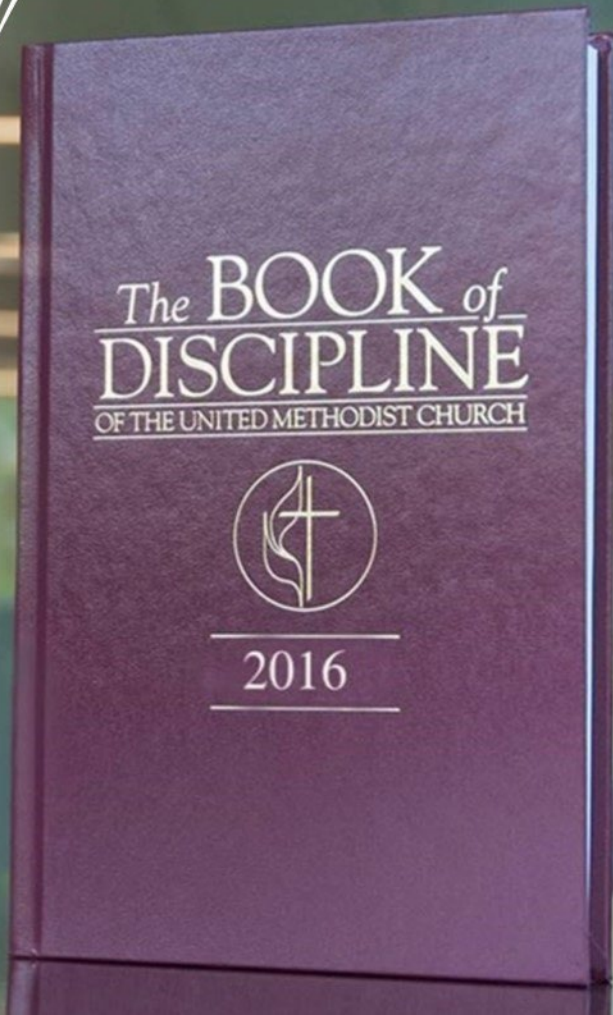

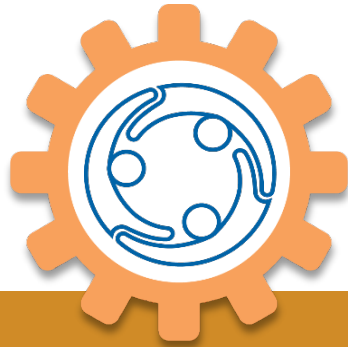


Wespath's Vision of a Sustainable Economy
