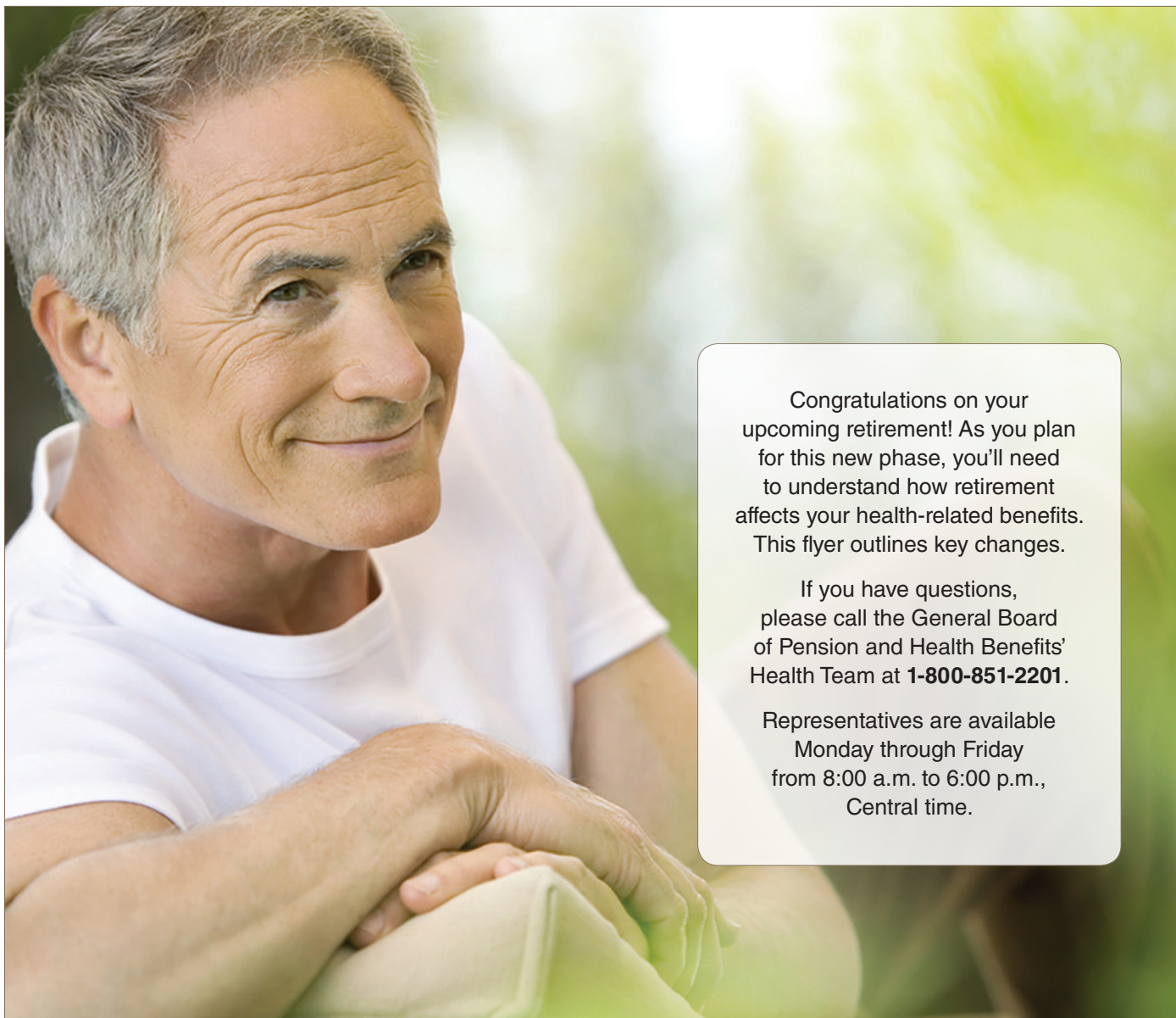

Caring For Those Who Serve

The following changes to your HealthFlex coverage apply regardless of your age at retirement.

<p>Medical/Pharmacy/ Behavioral Health Benefits</p>	<p>Your HealthFlex medical, pharmacy and behavioral health coverage will end on the last day of the month of your final date of employment. You may be eligible for your plan sponsor's post-65 retiree coverage, if offered.</p>
<p>Dental and Vision</p>	<p>Your dental and/or vision coverage will end on the last day of the month of your final date of employment.</p>
<p>HealthFlex Health Reimbursement Account (HRA)</p>	<p>If you have an HRA through HealthFlex, it will be converted to a HealthFlex Retiree HRA. Your HealthFlex Retiree HRA will function exactly as your previous HRA, except that you will also be allowed to use Retiree HRA funds to pay for your health plan premiums, including medical, pharmacy, dental and vision premiums, as well as Medicare premiums if you are Medicare-eligible. Your HealthFlex Retiree HRA will continue to be administered by WageWorks.</p>
<p>Flexible Spending Accounts (FSA)</p>	<p>If you have an FSA through HealthFlex, your coverage under the HealthFlex Medical Reimbursement Account (MRA) and/or Dependent Care Account (DCA) will end on the last day of the month of your final date of employment. Only eligible expenses incurred before your final date of employment may be reimbursed from your MRA or DCA. <i>Expenses incurred after your final date of employment are not reimbursable.</i> You will have only 90 days after the date your coverage ends to submit FSA claims for eligible expenses that were incurred through your final date of employment.</p>
<p>Virgin Pulse</p>	<p>Your Virgin Pulse eligibility will end on the last day of the month of your final date of employment. You have 30 days from the date your Virgin Pulse eligibility ends to "spend your HealthCash" through Virgin Pulse; after 30 days, your HealthCash balance will be forfeited.</p>
<p>All Other Wellness Programs and Incentives (Employee Assistance Program, Blueprint for Wellness, WebMD and all other Wellness Benefits)</p>	<p>Eligibility and access to all other wellness programs and incentives will end on the last day of the month of your final date of employment.</p>
