Calls for America to address systemic racial discrimination continue to dominate the news. Many corporations and organizations recently aligned with the Black Lives Matter movement, taking public stances against racial injustice and police violence, and committing to financially support organizations dedicated to addressing racial justice.

Wespath's General Secretary, Barbara Boigegrain, joined General Secretaries of all Church boards and agencies, as well as other Church leaders, to release a statement marking "this moment as a time to recommit to urgent action to dismantle racism in the United States and in the church" and committing to "look with new eyes and renewed commitment at matters relating to staffing, the make-up and leadership of our boards of directors and the allocation of resources to the important work of racial justice and equity."
