It's Midyear—Are You Earning Your Match?

Some plan sponsors offer money for your retirement, but only if you also contribute to your account. These contributions, often referred to as "matching" contributions, can have a big impact on the amount you save—it's like **free money for your future**.

If you are eligible for a match and aren't contributing enough to earn your full match—start now! Your *Contribution Election* can be changed at any time, and those matching contributions will start or increase as soon as you contribute more to your account.

If you are in the Clergy Retirement Security Program (CRSP), which requires a personal contribution of at least 1% to earn 1% from your conference, you can even make up for the months you've missed. [Learn more here](#).

HealthFlex Updates

Coverage for COVID Treatment and MDLIVE

Wespath strives to provide peace of mind for all HealthFlex participants and families during this global health pandemic. Therefore, we are extending COVID-19 coverage in *all HealthFlex plans* through **December 31, 2020** as follows:

- Both in- and out-of-network COVID-19 tests will be covered at 100%—as required by law
- **In-network** COVID-19 treatment will be covered at 100%
- MDLIVE telemedicine visits will be covered at 100%

This includes HSA plans—participants will not be required to meet their deductible before the plan begins to pay for these services.
