HealthFlex Updates

Important COVID-19 Coverage Information for HealthFlex Participants

Coverage will be extended until at least* January 31, 2021 for the following:

- COVID-19 testing covered at 100%
- At home COVID-19 testing (only if recommended by your doctor)
- In-network COVID-19 treatment covered at 100%
- \$0 copay for MDLIVE® online consultations

*These provisions may be extended beyond January 31 if the new administration extends the COVID-19 emergency period. We will communicate any updates to this coverage as soon as we have the information.

COVID-19 Vaccine Coverage

The vaccine will be covered as part of your medical and pharmacy benefit. When available, you can choose to receive it at your doctor's office or local pharmacy.

Flexible Spending Accounts (FSAs)

The recently passed Consolidated Appropriations Act allows plans to permit rollover of all remaining 2020 health and dependent care FSA amounts through 2021. We are currently working with HealthEquity to take advantage of this opportunity for HealthFlex participants. There is nothing you need to do at this time. We will share more information and details as soon as possible.

Wellness Program Transition to Virgin Pulse

Beginning January 4, it will be easier to access HealthFlex's award-winning well-being programs. The programs will be the same, but you will now access them through Virgin Pulse[®]—the popular HealthFlex activity-tracking website and app.

You will have the same wellness incentive programs but will just access the programs in a different way—through Virgin Pulse instead of HealthFlex/WebMD. Here are a few things you should know:

- Some of the programs have new names. Wellness Points are now called Wellness Credits. When you reach 150 Wellness Credits, you receive \$150 in Pulse Cash*.
- HealthQuotient or HQ, the online health assessment tool, is now called **Health Check**.
- One-on-one health coaching is now available through Virgin Pulse. Just as in prior years, certified professionals work with you over the phone to help you achieve your health goals.

For more information about your well-being programs and their new home in Virgin Pulse, <u>click here</u>. Access to HealthFlex/WebMD will still be available for at least several months in 2021.

* You must be enrolled in Virgin Pulse to earn Pulse Cash. The IRS considers incentives taxable income. Please consult your tax adviser.

RMDs 101 for 2021

The federal Coronavirus Aid, Relief and Economic Security (CARES) Act of March 2020 <u>waived required minimum distributions (RMDs)</u> from defined contribution (DC) retirement plans and IRAs that would have been due in 2020 or by April 1, 2021. Therefore, Wespath did not issue 2020 RMDs automatically for eligible participants.

What to expect in 2021:

- RMDs will resume automatically in 2021. RMDs for 2021 will be due by December 31, 2021. RMDs for 2020 that would have been due April 1, 2021 were also waived and will not be issued.
- If you did not request an RMD or receive any other distributions from Wespathadministered retirement plans in 2020, you will not receive a 2020 IRS *Form 1099-R*. If you did receive a distribution from Wespath-administered plans in 2020, your IRS Form 1099-R will be mailed no later than February 1, 2021.
